2019 Highlights



Holy Cross Medical Center

In October, management unilaterally imposed a new wage scale for the Advanced Practice Unit. The Union immediately filed an Unfair Labor Practice with the National Labor Relations Board. Rather than lose at the NLRB, management agreed to come to the negotiating table. All employees in the APC Unit on the old wage scale will receive a \$3 per hour wage increase.

University of New Mexico Hospital-

At UNMH, employee only health care is paid for by the Hospital. During negotiations in September, management proposed that employees pay a portion of their health care, wiping out this year's wage increase for many workers. The negotiating team stood strong and rejected management's proposal. The Hospital will continue to pay the employee only health insurance.

Christus St. Vincent Hospital—

In November employees in Service and Maintenance were subjected to antiunion statements from a Manager. This is a violation of the National Labor Relations Act and the Union has filed a charge with the National Labor Relations Board.

We are in difficult contract negotiations at Los Alamos Medical Center with a for profit company, LifePoint who is more interested in making a profit than providing quality health care for the community. We are working with our LA members to demand justice.

SPECIAL ELECTIONS UPDATE, Shane Youtz, District Attorney

As many of you know, your Executive Board unanimously voted to remove District President, Sharon Argenbright on September 7, 2019. Ms. Argenbright appealed this decision and the National Trial Board issued its decision on Ms. Argenbright's appeal on December 5, 2019. In that decision the National Trial Board indicated concerns about the District's action to "remove a President who was elected by the membership just four months earlier . . ." In order to remedy that concern, the National has deemed our office of President as vacant and has directed the District to "schedule an election for the office of President, to be supervised by the U.S. Department of Labor." Consistent with that direction, the District has already contacted the U.S. Department of Labor and we will be working with the DOL to schedule a special election as soon as possible for the office of President of the District. In the interim, the Executive Board and Executive Director, Eleanor Chavez will continue to work for you to grow our District and fight for our membership. Watch for upcoming election notices!!
